Eligibility

The Wisconsin Chapter of the American Society of Landscape Architects establishes a collection of Recognition Awards to recognize persons and organizations who have displayed great commitment to the profession of landscape architecture. Below is a list of actions that may deem a nomination for one of the awards. This list is by no means exhaustive and is open to interpretation.

- Enhanced the visibility of the profession of landscape architecture in Wisconsin.
- Promoted excellence in land planning and landscape design.
- Promoted professional ethics.
- Fostered environmental stewardship and enhanced quality of life.
- Promoted equity, diversity, inclusion and environmental justice.
- Fostered education, outreach and mentorship.

Entry Categories

Entries may be awarded within the categories listed below:

- Public Service Award
- Visibility Award
- Life Achievement Award
- Environmental Enhancement Award
- Chapter Service Award
- Chapter Support Award

The jury will be comprised of the WI ASLA board members.

Nomination Process

Nominations may be made by a WI ASLA member. Nominees should not be made aware of their nominations or asked to participate in the preparation of their nomination materials. Please include the following in your nomination:

- Nomination Form
- A letter of nomination describing the nominee's qualifications. The letter may be no more than three pages in length.
- Include three to five images representing the nominee's work.
- Photo of the nominee.

Deadline

All entries must be received by 5:00 PM CST on Friday, January 9, 2026

Award Winning Entries

The award winners will be notified several weeks prior to the awards ceremony. This year, we are pleased to announce that the Awards Ceremony will be hosted in conjunction with the WI ASLA Annual Meeting on January 30, 2026. Attendance at the meeting is not required. Winners will be notified by January 16, 2026.

Entry Categories and Nomination Details

Designate the appropriate category:

Public Service Award

- To recognize landscape architects or allied professionals who, as individuals or organizations, have provided exemplary community service on committees, boards, or through pro-bono projects at a local, state, or national levels.

Visibility Award

- To recognize an individual or a group who has significantly increased public awareness of the profession of landscape architecture through presentations, exhibits or publications.

Life Achievement Award

- To recognize an individual whose career has advanced the profession of landscape architecture in Wisconsin through extraordinary leadership and professional works.

Environmental Enhancement Award

- To recognize an individual or an organization that has shown innovative ways to incorporate environmental concerns into plans, designs or strategies for the built environment.

Chapter Service Award

- To recognize a landscape architect who has given exemplary service on chapter boards and committees.

Chapter Support Award

- To recognize affiliated professionals, vendors, and organizations who have shown exemplary support for the chapter and its activities.
